The Program

Where possible, information received from services at the time of booking is used to plan a developmentally appropriate program based on the age, needs and interests of the child.

Our service caters for children aged 6 weeks to 12 years of age, with a focus on 0 to 5 years.

The program is developed with particular reference to the Early Years Learning Framework: **Belonging, Being and Becoming**; so children

- have a strong sense of identity
- connect and contribute to their world
- have a strong sense of well being
- are confident and involved learners
- are effective communicators

About Mobile Minders

Bankstown Mobile Minders provides onsite childcare to enable parents/carers to attend and participate in community activities, education and health programs such as English Language Classes, Parent Support Groups and Health programs, etc.

This service is provided to non-profit Community, Government services and groups in the Bankstown Local Government Areas.

Service Priorities

Child minding is available to the following groups, and bookings will be processed in relation to our priority of access for receiving this service –

- 1. Isolated Culturally & Linguistically Diverse Groups (CALD) with limited access to childcare.
- 2. Aboriginal & Torres Strait Islander people with limited access to childcare.
- 3. Community groups that facilitate community development activities e.g. education, employment, health programs
- 4. Support and self-help groups.
- Government groups providing a community education service in a community setting.

THE MOBILE MINDERS SERVICE IS NOT AVAILABLE FOR FUNDRAISING ACTIVITIES OR PRIVATE CHILD CARE IN THE HOME.

Requirements

Bankstown Mobile Minders is not a licensed childcare service. Parents of children to be cared for must be on the premises at all times.

THE SERVICE CAN ONLY OPERATE ON THE BASIS THAT PARENTS/CARERS ARE ON THE PREMISES.

Staff will be allocated based on the number of children. We endeavour to follow the staff ratios set by the Department of Education:

1 minder to 4 children under the age 2 years 1 minder to 5 children between 2 to 3 years 1 minder to 10 children between 3 to 6 years

Premises

The building where the children are to be minded must be covered by Public Liability and an Insurance Policy, these details need to be included in the booking form. It is not the Bankstown Mobile Minders responsibility to open or secure buildings booked.

Responsibility

We aim to provide a supervised quality childcare service whereby every effort is taken to ensure the care of children however we accept no responsibility for accidents and misadventures while the children are being minded. Parents/Guardians will however be notified immediately should an accident occur.

Hours of Operation

We operate during school terms which is 40 weeks in the year. Hours of operation for childcare during the week are between 9am to 5pm.
